#### Ways to Submit Entry Form 遞交報名表方法:

- Apply online 網上報名:
  - 1. Complete the Entry Form on SQ18 official websites (www.am1470.com & www.fm961.com). 登入大會網頁並填妥網上參加表格。
  - 2. Upload Entry Song (mp3), Lyrics Sheet (doc) and Photo (jpg) of performer(s), if any. 上載參賽歌曲 (mp3)、歌詞 (doc)及演出者之照片 (jpg)。
  - 3. Pay by PayPal. If you do not have a PayPal account, you can pay by credit card but make sure the name and address are that of the credit card holder. 以 PayPal 付款。若你沒有 Paypal 賬戶,可選擇以信用咭繳付,但請填上信用咭持有人之姓名及地址。
  - 4. After making the payment, you will be assigned a reference number. After you log out, a confirmation email will be sent to you. 付款完畢後,若成功報名,你將會獲發參賽編號及收到確認電郵通知書。
- Apply by mail or in person 郵寄或親身報名:

#### Song Requirements 歌曲格式:

The Entry Song must be no longer than FOUR (4) minutes. Please also provide a music-minus-voice (MMO) track following the singing version. 參賽作品長度不能超過四分鐘,在完整歌唱版本之後請多預備一個伴奏音樂版本 (MMO)。

- A minimum of 50% of the lyrics (in terms of the length of vocal time) must be in Chinese (Cantonese or Mandarin). The lyrics shall not contain any obscene language or message that encourages discrimination or hatred. 歌詞部份最少須有 50%(以聲音演繹時間計)為中文(廣東話或普通話),不能包含任何粗言穢語或仇恨、歧視等訊息或字樣。
- Please do not include the Contestant's name on the mp3, music CD and Lyrics Sheet. 參賽歌曲之 mp3、audio CD 及歌詞均不能附有參 賽者姓名。
- A Contestant may enter up to FIVE (5) works, however each entry must be submitted individually. 參賽者最多可遞交五首參賽作品,但 每首作品須獨立報名。
- Each Contestant will not have more than one song selected for the "18th Canadian Chinese Song-Writers Quest". 每位參賽者最多只能有一首參賽作品入選「第十八屆加拿大中文歌曲創作大賽」決賽。
- All items included in the entry are non-returnable. 所有遞交的報名資料一概不予發還。
- The entry must be submitted to Fairchild Radio Vancouver Office on or before the Deadline for Entry. 參賽作品必須在截止日期前遞交至加拿大中文電台溫哥華辦事處。

(hereinafter called "Fairchild") and make the following representations, warranties and covenants: 參賽歌曲之作曲人、作詞人、編曲人及演出者(共成一個個體,以下稱「參賽者」),於填妥此參加表格、連同參賽歌曲及報名費遞交之同時,已即時與主辦機構加拿大中文電台(以下稱「加拿大中文電台」)簽訂具約束力之合約,並作出以下聲明、保証及承諾:

- the Composer, the Lyricist and the Music Arranger are Canadian Citizens or Permanent Residents or Landed Immigrants of Canada.

- 2. the Contestant is a resident of British Columbia or Alberta. 參賽者為卑詩省或亞伯達省之居民。
